STORMING THE HILL

undreds of Letter Carriers from across the country invaded Capitol Hill in the last week of February. Swarming the tunnels under the House and Senate buildings in "the other Washington", we met with our Representatives and Senators to discuss four issues essential to a vital public Postal Service: 1) 6-day mail delivery, 2) door delivery to households and businesses, 3) restoring service standards to July 1, 2012 levels (local overnight delivery of regular mail) and 4) anti-privatization. By asking our Representatives to cosponsor House Resolutions 23, 33, 54 and 60, we obtain commitments to these important issues, should a Postal Reform bill be introduced. In other words, if the proposed bill said USPS would force people and businesses to take delivery out of a cluster box or that USPS would do away with Saturday mail delivery (or Tuesday!), that bill would not fly. In the 115th Congress, we had bipartisan majorities in the House on all four and on the antiprivatization resolution in the Senate. In the newly minted 116th Congress, we are making good progress towards that goal. A majority of cosponsors in the House of Representatives is 218 or just over half of the 435 seats therein. There are ten Congressional Districts in the state of Washington.

I am the LCCL or Letter Carrier Congressional Liaison for District 10 in our state. I live in Spanaway, so my Representative is Congressman Denny Heck. Denny's district also covers Puyallup, Lacey, Olympia, Lakewood, Shelton, part of Pierce and much of Thurston Counties. Districts are redrawn to reflect census data, so with 7.4 million people in Washington, there are more or less than 740,000 people in each district. As all letter carriers are well aware, there are housing booms on some routes and others are fairly static, so districts will be redrawn with data from the 2020 US Census.

Out of our ten Representatives, seven have cosigned some or all of our Resolutions. Because I have been in frequent contact with Emily Kolano, Denny Heck's new Legislative Assistant in DC, Congressman Heck had cosigned all four of the House Resolutions before we even got to DC. Emily is much more accessible than the guy she replaced. I have been educating Emily on postal issues through emails and finally got to meet her when we went to Congressman Heck's office in DC. Denny even came by to say "hello" and give me a hug. Denny talked with Teauna Young's daughter Ceauna about college and then left Emily and us to hammer out the details. Unfortunately we were crammed into a small space and didn't get a photo

with Denny, but we also visited with Congressman Derek Kilmer (WA-6) in the Capitol and got to stand in front of a painting of George Washington. In the photo are letter carriers Mark Myers, Jim Hubbard, Congressman Kilmer and myself. I always tease Derek about Denny having to pick up his socks, because they room together in DC.

Brian gave us the encouragement and room to run the meeting. Representative Herrera Beutler, Brittany and I have the same place that we call home, Vancouver. She has always been on the side of carriers. We spoke about home, about the local carriers, and thanked her for signing on two resolutions, H. Res 23 and 54. Brittany spoke about meeting with Congresswoman Herrera Beutler's assistant, Piper. Brittany asked if she would be willing to sign on to H. Res 33, since she had signed on last year. She agreed!

After this lobby trip, I can really talk about things a union member can do to help their fellow carriers. Imagine what we could do if we all used our voice. I am still entranced with politics, but now I have an even better reason to be.

BEING HEARD

n February, I had the privilege to attend our national lobby trip with other members of the NALC from Washington State. We began our journey on Sunday, February 24th. While traveling via van to Crystal City, Virginia, State President Brian Wiggins gave us the rundown of what we were to expect during our time in Washington DC. I was slightly nervous, as this was my first time delivering the NALC's message to Capitol Hill.

On Monday morning, we all rode the Metro into the heart of Washington DC and arrived at NALC headquarters. Eddie Morgan, National Legislative and Political Organizer, briefed us on our talking points that we needed to focus on during our meetings with local congressional representatives. There were letter carriers from across our nation representing the individual states that attended the briefing with us.

On Tuesday, we finally got to meet with our congressional representatives. The first meeting I was able to attend was with Congresswoman Jamie Herrera Beutler, my representative from the 3rd District of Washington. Brian Wiggins and Vancouver Branch 1104 President Holly Curatolo were part of the meeting as well. Representative Herrera Beutler was very well versed on our cause. She had already co-sponsored on two of the four resolutions that we were there to speak about. H. Res 33 is the resolution that focuses on the solvency of the Postal Service, and opposes any measures to privatize our industry. Jamie pledged her support and assured us that she would become a cosponsor. The meeting was a success.

On Wednesday, we were able to meet with Representative Adam Smith (WA-9). He praised our union for our activism on Capitol Hill. He also pledged his support for our cause. On Thursday we met with aides from Senators Maria Cantwell and Patty Murray's offices. Both meetings went well.

All in all, I felt like the trip was a huge success. Our congressional representatives were more than willing to meet with us and hear our message. I felt that we were very well received, and I am very grateful that I was given this opportunity to represent our letter carriers of the NALC. I cannot tell you how impressed I was by the dedication and professionalism of my fellow delegates to the Lobby Trip. Their hard work and dedication, led by your State President Brian Wiggins, in improving the lives of hard working letter carriers is an impressive thing to be a part of. I urge all of you to get involved and support the cause of all letter carriers.

PROPOSED CHANGES TO THE WSALC BYLAWS FOR CONSIDERATION AT THE 2019 CONVENTION

#1 PROPOSED CHANGE TO ARTICLE 8, SECTION 1

Change the last two sentences of Article 8 Section 1.

Change "The President shall receive a salary, other than allowable expenses, a per annum salary equal to twenty (20) days City Carrier Grade 1, Step O pay, the hourly rate to be determined on July 1 of each year. This amount will be paid quarterly."

By deleting "other than allowable expenses, a per annum salary equal to twenty (20) days City Carrier Grade 1, Step O pay, the hourly rate to be determined on July 1 of each year. This amount will be paid quarterly."

Change by Adding "equal to forty (40) hours per quarter at City Carrier Step O pay, the hourly rate to be determined on July 1 of each year."

The Above Article will then read,

"The President shall receive a salary equal to forty (40) hours per quarter at City Carrier Step O pay, the hourly rate to be determined on July 1 of each year."

#2 PROPOSED CHANGE TO ARTICLE 8, SECTION 2

Article 8, Section 2 now reads:

Vice President

Section 2. The Vice-President shall preside in the absence of the President, as well as in any case involving the death, resignation, disqualification, refusal or neglect of the President to discharge the duties of the President's office until an election can be held. The Vice-president shall perform such duties as the President may require. The Vice-President shall assist in the organizing efforts throughout the State.

Change by adding a salary.

The Vice-President shall receive, other than allowable expenses, quarterly salary equal to four (4) hours at the Full Time City Letter Carrier, Table 1, City Carrier Schedule, Step O pay, the hourly rate to be determined on July 1 of each year.

Article 8, Section 2 would then read:

Section 2. The Vice-President shall preside in the absence of the President, as well as in any case involving the death, resignation, disqualification, refusalor neglect of the President to discharge the duties of the President's office until an election can be held. The Vice-president shall perform such duties as the President may require. The Vice-President shall assist in the organizing efforts throughout the State. The Vice-President shall receive, a quarterly salary equal to four {4} hours at the Full Time City Letter Carrier, Table 1, City Carrier Schedule, Step Opay, the hourly rate to be determined on July 1 of each year.

So, beyond just voting, contributing money or asking <u>our</u> elected representatives to support carrier-friendly legislation, how do we help protect our jobs and our families' future?

We can help elect other friendly candidates to House or Senate seats by volunteering to work on campaigns. This might include making phone calls, knocking on doors, helping mail literature or in many other ways. It is virtually certain that there is such a race near you anywhere in Washington State, and that they will need help in the next few weeks.

This work is sometimes challenging but always rewarding. You might be amazed how welcome a dependable letter carrier type would be! Just be sure you are off-the-clock and out of uniform when doing partisan political volunteer work to comply with federal and postal regulations. There is specific advice about this topic on the NALC website under *Government Affairs/Letter Carriers and the Hatch Act* or you can contact the National Business Agent's office (see Page 2).



As a member of the NALC, there are several easy ways to give to the Letter Carrier Political Fund:

- **1. Payroll deduction:** Contribute automatically, using PostalEase (either online or by phone) to set up an allotment deduction from your USPS paycheck.
- **2. Direct bank withdrawal:** You can authorize the fund to withdraw a monthly electronic contribution directly from your personal checking account
- **3. Annuity deduction:** Retired letter carriers can elect to give monthly via an automatic deduction from your monthly annuity.

If you need any help getting signed up, please fill out the form on the website at *Government Affairs/*Political/LCPF (only need your name, email, phone and branch number) and NALC will contact you to assist you in signing up to contribute.

By making a contribution to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that contributor. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 per calendar year. Any guideline amount is merely a suggestion, and an individual is free to contribute more or less than the guideline suggests and the Union will not favor or disadvantage anyone by reason of the amount of their contribution or their decision not to contribute.
